1. This agreement details the conditions for the HyCO 2DT Rebate Program Proposed in the Eagle-Research eNews and in the HyCO 2DT online Resources.

2. Costs - Money & Time

- **a.** The initial purchase price of each HyCO 2DT is USD \$3000 for the USA version (brand name Fuelizer) and USD \$2500 for the Columbia version; plus applicable shipping, taxes and handling charges.
- **b.** The purchase price is for the <u>pre-assembled canister only</u>.

Hoses, brackets, valves, fittings, wires, switches, LEDs, buzzer, etc. will be purchased by the Participant. (Estimate \$200 to \$500 additional cost depending on options chosen.)

c. For the first installation, *due to the learning process*, you should assume 16 hours on fabrication & 16 hours on installation. These times should reduce $\pm 75\%$ in production.

3. Consultation Help - for Rebate Program

I agree to provide specifications for parts, suggestions for acquiring parts (See Installation Manual and HyCO 2DT online Resources) and up to 30 minutes to verify that the parts you choose meet the HyCO 2DT standards.

4. I agree to be available for consultation (by Skype) as you install and test your HyCO 2DT(s). The first 30 minutes is free to Rebate Program Participants. Consultations need to be scheduled.

5. Guarantee

- **a.** The HyCO 2DTs sold under this agreement will be covered by the usual 'No questions asked, 60 day, 100% satisfaction or your money back' Eagle-Research guarantee.
- **b.** Each HyCO 2DT sold is considered separately for refund/rebate purposes.
- **c.** If a HyCO 2DT is returned for money back, any rebate already paid is considered part of the money back.

Rebate Qualifications & Participant Responsibilities

Participants can qualify for up to \$1000 of rebates

- **7. Rebate of \$100** will be given to Participants who:
- a. Test & record the vehicle's fuel mileage before & after the HyCO 2DT is installed.
- *Report to include* vehicle/engine specifications and at least one picture of the vehicle, preferably showing the HyCO 2DT installed.
- **8. Rebate of \$100** will be given to Participants who:
- a. Provide a before and after pollution test on the vehicle exhaust.
- *Report to include* vehicle/engine specifications, where tested and by what equipment and at least one picture of the vehicle as it is being tested.
- **9. Rebate of \$300** will be given to Participants who:
- **a.** Report a before and after dynamometer test of the HyCO 2DT that includes at least rpm, power and fuel consumption figures.
- Can be done at the same time by shutting off and turning on the HyCO 2DT.
- *Make sure* the HyCO 2DT system has operated for at least 15 minutes (to stabilize fluid levels in the HyCO 2DT canister) before starting that portion of the test.
- *Make sure* the HyCO 2DT has been turned off for at least 15 minutes of engine operation before starting that portion of the test.
- Report to include a picture of the truck being tested.

10. Rebate of \$500 will be given to Participants who:

- **a.** Keep a written Log (in a notebook), plus a photographic record of the installation. Videos are optional and would be very appreciated.
- *Notations* in the written /photographic / video Log will include: the date; name(s) of participant(s) involved, description of work accomplished; any issues found; how the issues were resolved; descriptions of tests: the results of the tests.
- **b.** Provide copies of receipts for parts and labor.
- **11.** Participants agree to send legible (written in English or with English translations) copies / scans of the mileage comparisons, Log, photographs, video and, if applicable, pollution data and dyno tests, before receiving the applicable rebate(s).

12. Participants will:

- **a.** Verify the information sent to be true and accurate.
- **b.** Agree to have any or all of the information used as promotional material.
- **13.** To qualify for the HyCO 2DT REBATE PROGRAM you do need to send in the signed Rebate form **before** you receive the HyCO 2DT. (send via email or FAX)
